**PERATURAN-PERATURAN PIHAK BERKUASA BERSAMA MALAYSIA-THAILAND

**MALAYSIA-THAILAND JOINT AUTHORITY ACT 1990**

**MALAYSIA-THAILAND JOINT AUTHORITY (TERMS AND CONDITIONS  
OF APPOINTMENT OF CO-CHAIRMAN AND OTHER MEMBERS OF THE AUTHORITY)  
(AMENDMENT) REGULATIONS 2016**

IN exercise of the powers conferred by section 15 of the Malaysia-Thailand Joint Authority Act 1990 [Act 440], the Minister, with the approval of the Governments, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Malaysia-Thailand Joint Authority (Terms and Conditions of Appointment of Co-Chairman and Other Members of the Authority) (Amendment) Regulations 2016**.

(2) These Regulations are deemed to have come into operation on 1 July 2016.

**Amendment of Schedule**

2. The Malaysia-Thailand Joint Authority (Terms and Conditions of Appointment of Co-Chairman and Other Members of the Authority) Regulations 1993 [P.U. (A) 412/1993] are amended in the Schedule by substituting for Table II the following Table:
