

**MALAYSIA-THAILAND JOINT AUTHORITY ACT 1990**

MALAYSIA-THAIAND JOINT AUTHORITY (TERMS AND CONDITIONS  
OF APPOINTMENT OF CO-CHAIRMAN AND OTHER MEMBERS OF  
THE AUTHORITY) REGULATIONS 1993

**In exercise of the powers conferred by section 15 of the Malaysia-Thailand Joint Authority Act 1990, the Minister, with the approval of the Governments, makes the following regulations:**

1. These regulations may be cited as the Malaysia-Thailand Joint Authority (Terms and Conditions of Appointment of Co-Chairman and Other Members of the Authority) Regulations 1993 and shall be deemed to have come into force on the 7th February 1992.

2. A Co-Chairman and a member of the Joint Authority shall hold office for such term as shall be determined by their respective Governments.

3. (1) The office of a Co-Chairman and a member of the Joint Authority shall be vacated—

- (a) if he dies;
- (b) if he becomes insolvent or bankrupt;
- (c) if he is adjudged incompetent or quasi-incompetent;
- (d) if his appointment is revoked by the Government appointing him.

(2) Where there is any change in the appointment of a member of the Joint Authority, the Government responsible, through the Minister, shall inform the Joint Authority of such change.

4. The Co-Chairman and other members of the Joint Authority shall be paid such remuneration and allowances—

- (a) for the period of the pre-production phase, as is specified in Table I; and
- (b) for the period of the during-production phase, as is specified in Table II, of the Schedule.

5. Any member of the Joint Authority, including a Co-Chairman, who has any personal interest incompatible with his duties in the Joint Authority shall declare that fact to the Joint Authority without undue delay.

6. (1) The Co-Chairman and other members of the Joint Authority shall act bona fide at all times in accordance with the terms of the Agreement.

(2) No member of the Joint Authority shall incur any personal liability except to the extent specified in Article 5 of the Agreement.
